Background of :- Laxman Devram Sonawane College

Kalyan Wholesale Merchants' Association is playing a very significant role in the social, cultural and educational life of Kalyan city. The Association has created a sound goodwill in the vicinity of the Kalyan by actively participating in various welfare and socio-economic activities. NCG 2002 NMV 01,2002 from the Higher and Technical Education Division, Mantralaya, Mumbai-400032 dated 15th July 2003. The University of Mumbai issued a formal permission letter to enroll the students on 22nd August, 2002, vide letter no. Aff/Recog/4031 dated 22/8/2002.

The Laxman Devram Sonawane College would provide the following:

1. Classroom space, with suitable seating arrangement for Approx 50 students at a time.
2. 15th Computers.
3. Internet connection
4. Electricity
5. Day to day housekeeping facility
6. Access to washroom for both ladies & men
7. Adequate security.


Anudip foundation would provide faculty, training material, suitable curriculum and sector specific job oriented skills to enhance student's employability skills with an overall goal to find suitable employment to the under privileged student.

Class Schedule:

Anudip would impart training to each batch of students as per the mutual consent. Total training period for each batch of students would be according to the course opted by the

students. Classes would be held in Offline/Online mode.

Course fees:

Laxman Devram Sonawane College will pay Rs.750/- per student to Anudip Foundation as a course fees.

Payment terms :

After receiving complete course fees from Laxman Devram Sonawane College, Anudip Foundation will pay to Vendor a sum of Rs.750/- per hour for usage of the said premises. A log will be maintained by the faculty provided by Anudip Foundation for the calculation of monthly hours, based on which the vendor will raise an invoice and the payment will be made once in every calendar month.

The Laxman Devram Sonawane College agrees to the following terms of engagement:

- 1) Vendor will not charge any money to the students in excess of prescribed student's fee and promptly deposit the collection for a day into the bank account of Anudip Foundation.
- 2) Vendor will not copy, sell or use Anudip Foundation's curriculum to teach any other student who is not registered with Anudip Foundation as a student.
- 3) Vendor will ensure that all data related to students, courseware and all other relevant details are kept confidential and are not shared with any other third party, without the consent of Anudip Foundation's management in writing.
- 4) After termination of the project the Vendor -
 - a) will not project himself as a partner of Anudip.
 - b) will not use any logo of Anudip on its premises.
 - c) will not use the course material / courseware which he acquired for the practical session period.
 - d) Will not collect any money from anybody on behalf of Anudip Foundation.

Duration

This MOU is valid from (14th Sept 2022) to (31st March 2023). The duration of the MOU may be extended in mutual consent on expiry of this agreement.

Confidential information shall also include, without limitation, any materials, trade secrets, intellectual property, know-how, proprietary information, business and marketing plans, financial and operational information, and all other nonpublic information, analysis, reports, studies, summaries, extracts or other documentation, material or data relating to the current and/ or future business and operations of either Party.

Either Party agrees to keep confidential all such Information and shall not disclose the same, either in whole or in part to any person or any other third party without prior written consent of the other. Both Parties agree that it shall not during the Term of this Agreement and for a period of three (3) Years thereafter, disclose to any person any secret / Confidential Information with respect to matters or business affairs of the other in its possession or which either Party may come to know during the Term of this Agreement.

Both Parties agree that it may be provided with or may have access to written information/ data and/or other confidential information which is proprietary and/or confidential to the other. Or which it would be reasonable to assume was proprietary or confidential due to the nature of the information disclosed.

Both the parties (Laxman Devram Sonawane College and JLES) have had preliminary discussion to commence the **Employment Oriented – Skills based Training** sponsored by **Tech Mahindra Foundation (TMF)** and to be executed by JLES for the students of Laxman Devram Sonawane College.

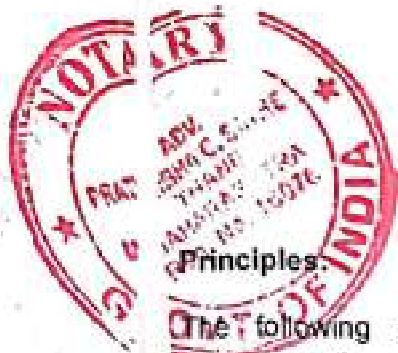
The Parties now have therefore agreed to enter in within these areas of consensus under the respective Memorandum of Understanding (MoU)

Preamble:

Laxman Devram Sonawane College & JLES have important roles in the Delivery of Education in their respective form / stream while working together on the Skill Development with Employment Oriented Programs complimented by Short Term Courses (STC) thereby truly enhancing the ability of each institute to fulfill the sole objectives.

This MoU will promote co-operation, collaboration, effective communication and reciprocal facilitation between Laxman Devram Sonawane College and JLES; focused to build on the existing strengths and collaboration activities of both the Institutions. Also, while not creating a binding or legal obligation on either institution provides the basis of their relationship.





Principles:

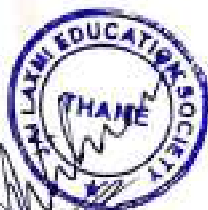
The following are the principles for the framework for the development and implementation of this respective Memorandum of understanding with resulting activities:

- Collaboration under this MoU will not change the Identity or Status of either Institution and both the institutions recognize that each brings particular strength and expertise to achieve the said objective
- The implementation of this Memorandum will at all times be based on mutual respect and co-operation rather than competition
- Open and timely communication, consultation for drafting action plans if required
- Sustainability and appropriation of course offerings with Quality Benchmarks
- Ensure that the students have increased opportunities to participate in the Skill Development and Industry led Programs in conjunction with their respective - Academic Qualification

Potential Areas of Collaboration:

Training & Skill Development: The Employment Oriented Program - 'Diploma in Accounting & Finance (DAF)' 250 Hours / 'Diploma in Digital Strategies (DDS)' complimented for 200 Hours would be conducted for Laxman Devram Sonawane College students through the **Offline / Online** medium / platform and the respective College authorities have to ensure on the requisite permissions to ensure smooth operations across.

Advertisement & Branding: The Sponsored Program shall be co-branded by both Laxman Devram Sonawane College & JLES on its promotional Collaterals with the respective sponsored partner where ever is appropriately required.





Responsibilities of JLES

JLES will be the party to do Registrations and Enrollment process for Employment Oriented – Skill based Training

- JLES will arrange for Aptitude Tests, Pre - Screening of Candidates and do the requisite analysis before enrolling for the said Programs
- JLES will collect only prescribed Enrolment Fee of INR 500/- (Five Hundred Rupees) from the students and will also design the lecture schedule. (Any Additional Fees shall be refundable)
- JLES will conduct Training of respective Modules through Industry Experienced Faculties to ensure Quality outcome
- JLES will assess, monitor and manage the respective faculties for Employment Oriented Programs (DAF / DDS) and also shall guide in terms of various resources
- JLES will do the timely Audits to ensure Quality Training is imparted and meet the set standards, maintaining quality assessment reports of the teaching learning plan and acknowledge to Laxman Devram Sonawane College on the progression status
- JLES, if required, will also help in doing the telephonic counseling to the students and provide guidance to them on career prospects with Skill Development Programs
- JLES will assist the students in Internship with Gamification and provide OJT / Placements Opportunities in the Mumbai / Thane region
- JLES shall attract and introduce sponsorships from CSR funds wherever possible for Employment Oriented – Skill based Training Programs
- JLES shall honor the Tax liabilities i.e. GST if any or shall mutually derive an understanding as per the respective situation / arrangement.





ICES shall facilitate the payment under #Giftacareer campaign, a 'Student Development Contribution' of INR 600/- per enrolled beneficiary on their successful completion of the DAF/DDS Program i.e. Post 04 Months from commencement Date of the respective Batch (es).

Responsibilities of Laxman Devram Sonawane College:

- Laxman Devram Sonawane College is responsible to assist in promoting and spreading awareness about the Employment Oriented – Skill based Training among student community
- Laxman Devram Sonawane College will promote / advertise and provide related assistance to enroll the students & formulate a batch of minimum 50 candidates. Also, shall share the respective Student details with JLES
- Laxman Devram Sonawane College shall provide permission and access to the student documents whenever required by JLES to complete its documentation process.
- Laxman Devram Sonawane College shall provide a replacement of a candidate in case of discontinuance from DAF / DDS within 15 days of Batch Freeze.
- Laxman Devram Sonawane College shall seek an official consent from JLES for usage of JLES Logo and other associates i.e. CSR Partner's logo for any promotions for Skill Development initiatives at College campus





• Laxman Devram Sonawane College will do the branding of JLES as "Skill Partner" and JLES will initiate the design and provide the essential collaterals

- Laxman Devram Sonawane College will not claim the partnership with associate CSR Partner's directly as it violates the law by doing so
- Laxman Devram Sonawane College shall seek consent or assistance before floating any promotional materials for JLES led any Employment Oriented – Skill based Training Program.

Examination:

The Exams for Employment Oriented – Skill based Training Program / Short Term Courses (STC) will be conducted as per the draft guidelines between JLES & CSR partner's, either system based or paper based. Final certification is awarded by JLES, CSR Partner(s) and Associated bodies / Institutions (fees to be paid by candidates).

Indemnification:

Not outstanding any other forms of these Memorandum both the parties shall identify, defend and hold each other against any claim liability, cost damage, deficiency, loss, expenses or any other connection with breach by party of the one part of any representation, warranty or covenants made in this MoU.

Arbitration:

In the event of any dispute arising in respect of any provision of this MoU the parties or their representation will be referred to the new arbitrator, to be chosen unanimously by both the parties and in case of difference of opinion between them the umpired selected by them such procedures shall take place in Mumbai / Thane.

That either party can terminate this agreement by giving to other 06 calendar month's - notice in writing. If and to the extent that the either party or prevented by circumstances not within its reasonable ability or control from performing any of its obligation under MoU and promptly so notifies the other party giving full circumstances in question then the party so affected shall be relieved of liability to the other for failure of the performance shall obligation out shall nevertheless use its best full performance thereof without avoidable delay, pending and such resumptions shall permits and shall use it





endeavors to facilitate any effort the other party may take to procure alternative products and services.

Under any circumstances, the other party (Laxman Devram Sonawane College) to contract cannot associate with respective CSR Partner's directly on any grounds for a period of at least **36 months** from the date of termination of the said contract as a freeze period so as the Brand Reputation and the expertise of first party (JLES) is not put in jeopardy at any cost.

All notice, legal or otherwise to parties is deemed and received and irrevocably valid upon the dispatch by courier to the respective parties, address as appended here under in this clause and any changes to the parties address shall be informed to the other from time to time. All other communication by the parties' representative to give respect to the generality of the MoU shall be by way of email and or any other mode specified by the parties at their convenience from time to time.





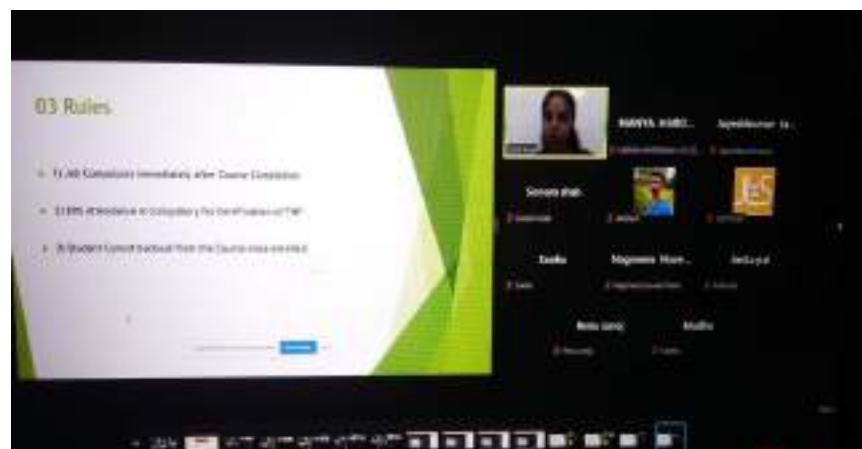
